Scope of Change

The Idaho Cleanup Project (ICP) is now operated for the U.S. Department of Energy by Idaho Environmental Coalition, LLC (IEC). Changes in controlled document ownership, applicability, and title references described below are a result of transition activities between Fluor Idaho, LLC and Idaho Environmental Coalition, LLC. These changes apply to all employees performing work for the ICP.

Controlled Document Ownership and Applicability
