The Idaho Environmental Coalition, LLC (IEC) is committed to incorporate sound environmental management policies and practices into all of its work planning and execution activities in order to implement the Idaho Cleanup Project (ICP) in a safe, compliant, and cost-effective manner that protects human health and the environment. This environmental policy provides the framework for setting environmental objectives and includes our commitment to continually improve environmental performance.

IEC implements an Environmental Management System (EMS) as a part of its Integrated Safety Management System. Using a graded approach appropriate for the ICP, the EMS includes performance goals and identifies and manages our organization's environmental risks and opportunities. It ensures that environmental considerations, including the protection of natural resources, the control and attenuation of risks, the prevention of pollution, and the acquisition of sustainable products and services are incorporated into processes throughout the organization.

This policy applies to all persons working on behalf of the ICP. Everyone is expected to follow this policy and report environmental concerns to management. The following principles have been adopted to achieve environmental excellence.

### **Leadership Commitment**

- Integrate appropriate environmental practices into all project operations; document environmental objectives and targets; measure progress; and report performance through the EMS.
- Educate employees on their environmental responsibilities and train them to ensure they comply with all requirements.
- Continuously improve our EMS through self-assessment and corrective action.
- Promote environmental stewardship, take prompt action to address concerns and issues, and have zero tolerance for noncompliance.

### **Environmental Compliance and Protection**

- Identify and comply with all applicable and relevant and appropriate environmental laws, regulations, and permits.
- Assess the effects of operations on the environment through a comprehensive environmental monitoring program.
- Provide full disclosure and openness with the Department of Energy and regulatory agencies regarding any noncompliance with regulatory requirements.

**Environmental Stewardship**

- Protect the unique natural, biological, and cultural resources associated with the ICP.
